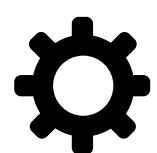
Data privacy policy ICAI Dubai chapter NPIO is developed as per the Data Protection Law DIFC, Law No. 5 of 20 which defines the purpose of storing, processing and protection of data subject (hereinafter referred as "member" of ICAI Dubai Chapter) personal information.



DATA CONSENT- FOR **STORING** INFORMATION

Data Protection Law requires ICAI Dubai Chapter NPIO to obtain affirmative Data Consent in order to **STORE** member personal information to communicate with members for the purpose of chapter activities including organising events, sending notifications, notices, updates, seeking members expression of interest, surveys, CSR activities, etc. Please click the link to provide the confirmation to **STORE** information.

DATA CONSENT- FOR **PROCESSING/SHARING** INFORMATION

Data Protection Law requires ICAI Dubai Chapter NPIO to obtain affirmative Data Consent in order to **PROCESS and SHARE** member personal information with third parties as specified below for the purpose specified in respective sections,

1. Contestants for the election of the Managing Committee: ICAI Dubai Chapter may share your information with the Contestant for the purpose of election of the Managing Committee. Election contestant provides ICAI Dubai Chapter NPIO a consent that post-election, they will destroy the information. However, please note that ICAI Dubai Chapter NPIO has no control over the contestants for protecting your information and not misusing later-on, being an Individual Member who is not governed by the DIFC data privacy law.

2. Sponsors of ICAI Dubai Chapter: ICAI Dubai Chapter may share your information with the sponsors of ICAI Dubai Chapter to provide you with their product promotions, sought your interest in their service/product offerings, update on their promotional offer. Sponsors may contact you through email or through telecon or any other medium. ICAI Dubai Chapter takes an undertaking from all sponsors to destroy the information at the end of the contract period. These processes may result in the export of Personal Data outside DIFC to jurisdictions that may not have an adequate level of data protection laws.

3. Sharing with Third-Party for conducting Elections: ICAI Dubai Chapter may share your information with the company carrying out the election of the Managing Committee appointed by the ICAI Dubai Chapter for the purpose of conducting the election. These processes may result in the export of Personal Data outside DIFC to jurisdictions that may not have an adequate level of data protection laws.

4. Other Third Parties: ICAI Dubai Chapter may share your information with the event management company or other companies for carrying out the activities of the chapter. These processes may result in the export of Personal Data outside DIFC to jurisdictions that may not have an adequate level of data protection laws.



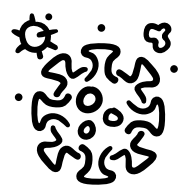
YOUR RIGHTS
